This breeding is not to be sold or transferred without the written permission of the **Stallion Owner** and **has to be used in the 2017 or 2018 breeding season.**

**FEES:**

1. The breeding fee is 3.500,- euro

**CONDITIONS:**

1. This breeding contract entitles the **Mare Owner** to one breeding to **AJ PORTOFINO** with one breeding certificate being issued per contracted mare.
2. In the event the contracted mare fails to conceive within three (3) heat cycles the **Stallion Owner** reserves the right to require the contracted mare to be cultured or biopsied to determine breeding soundness. The **Stallion Owner** also reserves the right to refuse service to any mare upon detection of an infectious and /or contagious disease. In the event of such discontinuance, the **Mare Owner** is obligated to substitute another mare to fulfill the terms of this agreement.
3. Should the contracted mare become ill, injured or is otherwise unable to conceive a foal the **Mare Owner** may substitute the mare.

4. The **Stable Owner** will supply fresh semen of the stallion concerned by this contract but does not guarantee the state of the semen starting from the moment it has been sent. The **Mare Owner** is responsible for the correct handling of the semen and insemination of the mare. The Stable Owner nor their employees are not liable for incorrect handling of the semen and/or insemination of the mare.

5. The **Stable Owner** will not be considered responsible for delayed delivery of the semen from the carriers. In case the shipment of the semen gets lost or is delay by the currier, the **Mare Owner** will have to refuse the package once it eventually gets delivered, so that the Stable Owner will not be responsible of the payment of the shipment. Should the **Mare Owner** accept a late delivery, he or she will have to pay the semen collection and shipment.

**LIVE FOAL GUARANTEE:**

1. Ajman Stud guarantees a return breeding within this breeding season or the following season either for the contracted mare or an approved substitute, should a live foal (defined as one that stands and nurses without assistance for 24 hours) not result from this breeding.

2. Should the foal be born dead or die before standing and nursing at 24 hours of birth, written statement from the **Mare Owners** licensed veterinarian stating the time and date of birth and the time and date of death shall be sent to the **Stallion Owner** within two (2) weeks of foals death.

3. Should the stallion die or become unavailable and should semen (fresh or frozen) no longer be available, Stallion Owner will no longer be responsible to fulfill this contract.

**INDEMNITY:**

Ajman Stud, as **Stallion Owner** and its owners, agents, employees, veterinarians shall not be liable for any sickness, disease, theft or injury which may be suffered by the contracted mar and/or resulting foal and/or semen during the breeding period of the contracted mare.

This contract constitutes the entire agreement between both parties and may not be modified except in writing and agreed upon by both parties.
